Enrollment & Registration Procedures

Required Forms:

In order to participate in any Serious Fun program, you (the child's legal parent or guardian) must submit hard copies of completed and signed registration forms (3 pages) to the Serious Fun by mail or email. These forms only need to be completed and submitted once each year; these forms will be kept on file with Serious Fun for one year so that you will be able to enroll your child in another Serious Fun program by submitting tuition payment. Please submit one form per child.

Payment Procedure:

Your child's enrollment in any Serious Fun program is not guaranteed until full payment is received. Payment may be made by check or money order made out to Serious Fun, LLC or by credit card using our online registration service at http://www.seriousfun21.com. You do not need to have a PayPal account to use this service: you will be asked to provide your credit card information.

Enrollment Policies

Enrollment Deadlines:

The enrollment deadline for all Programs is **7 days prior to the start of the workshop**. Enrollment information and tuition payment must be received by 6:00pm on the date of the deadline. Payments received after the deadline may incur a \$20.00 late fee. We reserve the right to cancel programs that have not reached a minimum number of participants. We would do this no later than the full week prior to the start date of the program.

Cancellation Deadlines:

You may cancel an enrollment up to **7 days prior to the start of the workshop** and receive a partial refund (tuition payment minus \$35). Refunds will not be granted after this deadline unless another student can take the space. Enrollment in any Serious Fun workshop is not guaranteed until full payment is received. Refunds will take 2 to 3 weeks to process.

Other:

- Programs in which the minimum enrollment has not been reached may be cancelled
- Returned checks will incur a \$35.00 over draft fee

Make-ups and refunds are not provided for missed classes; program cost will not be prorated for partial week attendance unless it is arranged before hand. Programs cancelled due to inclement weather or illness of the instructor will be made up. Refunds will be prorated, if no agreement can be reached about rescheduling. Processing of these refunds will take 2-3 weeks.
